

PRIVACY STATEMENT

for the processing activity Gov2Gov Platform

1. INTRODUCTION
<p>This Privacy Statement describes the measures taken to protect your personal data with regard to the action involving the present data processing operation and what rights you have as a data subject.</p> <p>EDA protects the fundamental rights and freedoms of natural persons and in particular their right to privacy with respect to the processing of personal data (Article 1.1 of Regulation No 2018/1725).</p>
2. CONTROLLER OF THE PROCESSING OPERATION

3. PURPOSE OF THE PROCESSING
<p>The purpose of this processing operation is to register authorised governmental users to the EDA Gov2Gov Platform. The Gov2Gov Platform is set up and maintained by EDA to support Member States in coordinating joint initiatives. Personal data of registered users are made available to all registered users to facilitate the necessary communication between Member States in the coordination of joint initiatives.</p>
4. DATA PROCESSED
<p>Categories of persons: registered users, in their capacity as competent staff of Member States' authorities.</p> <p>Categories of data processed: Name, Surname, e-mail address, telephone number, MS represented, professional affiliation. Contact details of MS project managers and associated project titles.</p>
5. RECIPIENTS OF THE DATA
<p>Internal recipients: EDA IT administrators and competent staff of the EDA CAP Directorate for verification of the registered users.</p> <p>External recipients: Other users registered to the Gov2Gov Platform.</p>
6. PROTECTION AND SAFEGUARDING OF THE DATA
<p>EDA has implemented appropriate technical and organisational measures (firewalls, checkpoints, antivirus) to ensure a level of security appropriate to the risks represented by the processing and the nature of the personal data to be protected. Such measures have been taken in particular to prevent any unauthorised disclosure or access, accidental or unlawful destruction or accidental loss, or alteration and to prevent all others unlawful forms of processing.</p>
7. RIGHT OF ACCESS AND RECTIFICATION OF THE DATA
<p>Data subjects have the right to access their personal data, the right to request rectification of any inaccurate or incomplete personal data, the right to erasure, the right to restriction of processing,</p>

the right to object to the processing, the right to withdraw their consent, the right to not be subject to automated decision making , as applicable and at any time.

8. TIME LIMIT FOR STORING DATA

Personal data is retained as long as the user account is active. Personal data are deleted when a user deactivates its account or when EDA terminates the user account for inactivity. Personal data are deleted when EDA terminates the deployment of the platform.

9. LEGAL BASIS FOR THE PROCESSING OPERATION

The legal basis of processing is Article 5(1)(a) and (d).

Processing is necessary to perform the tasks carried out by EDA in public interest. EDA processes the personal data of the registered users to ensure the functionality of the Platform and fulfil the tasks carried out by the Agency under Article 5 of the Council Decision (CFSP) 2015/1835 of 12 October 2015 defining the statute, seat and operational rules of the European Defence Agency.

The data subject has given his/her consent to the processing of his/her personal data as required for the registration to the Gov2Gov Platform.
