**Defence cooperation** – On 6 March 2018, the Council of the European Union adopted a roadmap for the implementation of the Permanent Structured Cooperation (PESCO). This roadmap provides strategic direction and guidance on how to structure further work on both processes and governance. The initial list of 17 collaborative projects has been announced by the Council.

**EU COSME funds transnational defence cluster partnerships** – Two transnational defence-related cluster partnerships, whose members have been working with EDA, informed the Agency that they have started negotiation of a grant agreement in view of being awarded <u>COSME</u> funding under a European Commission's <u>call for proposals</u>, managed by the Executive Agency for Small and Medium-sized Enterprises (EASME).

Defence Test & Evaluation Base (DTEB) - DTEB Members from Germany,

France, United Kingdom, Sweden, Luxembourg. Greece, Italy and Portugal met in Madrid to discuss the Terms of Reference and the Scope of Work (SoW) for the establishment of a Land Test Centres Network of Excellence (LTE). The SoW comprises Test & Evaluation and standardisation activities on vehicles. Subsequently, the LTE plans to call for a new EDSTAR Expert Group (EG) on "Land Vehicles including Autonomy", including industry's participation.
