Maritime situational awareness is the effective understanding of activities, associated with and occurring in the maritime domain, which could impact on the security, safety and environment of the European Union and its Member States.

Following a tasking by the EU Defense Ministers in late 2005, EDA launched the Maritime Surveillance project (MARSUR) in September 2006 to create a network using existing naval and maritime information exchange sys¬tems. The overall goals are to avoid unnecessary duplication of effort and the use of available technologies, data and information; to enhance cooperation in a simple, efficient and low-cost so¬lution for civil-military cooperation; and to support safety and security. It contributes an important capability in the context of the EU Maritime Security Strategy.
