Participation in EDA's public procurement procedures is open on equ terms to all natural and legal persons coming within the scope of the E Treaties. When applying the rules of access to the market, it is the countr where the tenderer is established which is to be considered. As regards natural person, it is the State in which the person has his domicile. EDA procurement procedures are not covered by the WTO Multilater Government Procurement Agreement (GPA). Tenderers established in thir countries (non-EU countries) do not have the right to participate procurement procedures unless international agreements in the field of public procurement grant them the right to do so.
