### What is its added-value for Industry?

The first European defence business portal of its kind, bringing new benefits to its audience at no cost and minimum effort.

- Promotes contract opportunities of defence buying organisations (Prime Contractors / 1<sup>st</sup> & 2<sup>nd</sup> Tier Suppliers) and attracts a potentially untapped audience of suppliers (non-standard Supply Chain).
- Expands the market research capabilities of defence-related Suppliers (especially SMEs).
- Drives value through the Supply Chain by introducing more transparency, fairness and competition.
